Subject: Early mandatory trainings before proceeding to Offshore.


Respected Sir,

Your authority is aware that we have nearly completed all the formalities of recruitment along with medical test for ATs & JATs, the present batch being very big and also simultaneously posting of GTs is also done, has created overcrowding in all three accommodation area like Santacruz Guest house, Poonam Nagar Transit camp as well as Panvel Colony, without overlooking the fact that ON/Off officials are also needed to be accommodated in Santacruz Guest House, naturally it is becoming unmanageable.

Presently all those who have completed 10 days stay are asked to manage their own accommodation, it need not be elaborated how expensive rental accommodation is in Mumbai, as far as in Panvel, one Bed Room kitchen flat is available with great difficulty for Rs. 10000/- (Rupees Ten thousand) per month with a deposit of Rs. 50,000/- (Rupees Fifty thousand), this being practically beyond the reach of AT/JATs, we request your esteemed authority, moreover when it is mandatory, kindly send this boys for training in Goa, Goregaon or Coloba at the earliest and give them posting to their designated Offshore installation.

It is also earnestly requested that till such time their trainings are completed and offshore posting is done allow them to continue in the provided accommodation, as rental accommodation for a month or two is not encouraged by flat owners in Mumbai.
