
The said individual had send a reminder on 10/12/2013 elaborating his plight, this unique decision of extending medical facility to DOD is getting blackened by such delays.

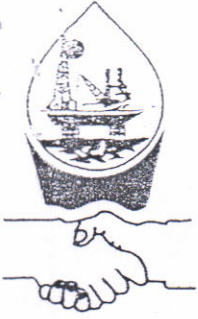

Subject : Medical assistance to dependents of employees who die while in service.


Respected Sir,
