**Subject : Request to review the case of Smt. Sunanda J. Jadhav of  
Asha Kiran Scheme.**

Respected Sir,

This has reference to the application received from Smt. Sunanda J. Jadhav wife of Late Shri. Jnanardan J. Jadhav ex employee of ONGC bearing CPF No. 39108, who expired on 1<sup>st</sup> May'2006 after serving 31 years in ONGC.

Smt. Sunanda J. Jadhav had applied for financial assistance under "Asha Kiran Scheme" (2014-2015) on 13/02/2015. Her medical certificate is certified by Dr. Meena Biswal, DGM (Med) on 13/02/2015 only) Smt. Jadhav had not submitted bill for "Fabrication of railing support for safety") which she submitted on 8<sup>th</sup> May'2015. Her claim has been denied by the committee for late submission of above mentioned bill.

Sir we have started this scheme to help the ONGC employees who have superannuated / expired before 31/12/2006. It is likely that out of ignorance ex employees wards are claiming for Asha Kiran Scheme only for second time may make mistakes. We want to mention that most of them are staying / settled out of Mumbai, for any single mistake they have to spend their whole day in ONGC office.

Smt. Sunanda J. Jadhav has submitted her claim in time i.e. on 13 Feb'2015, but the bill was submitted in month of May. For her small mistake denial of her claim by the committee of **Rs. 1.10 Lakh (Rupees one lakh and ten thousand only)**, is not justified. This scheme has been started to help our demised employees wife who are is getting meager amount of PRBS. Smt. Sunanda J. Jadhav is receiving Rs. 1195/- only under the ONGC pension scheme PRBS.

We request your esteemed authority to review the case as still our ex employees, widows are not familiar with the scheme, some of the widows are illiterate also. Considering all these facts, we are sure that her case will be given due consideration under your wisdom. Such refusals will only loose the purpose of the scheme.


