However ONGC Regional Office Mumbai has gone ahead and opened the price bid before verifying the documents of **M/s. Geruda Support Services Pvt. Ltd.** It is understood that the experience certificate submitted by **M/s. Geruda Support Services Pvt. Ltd.** is not issued by **M/s. Jagson International.**

We, once again request your esteemed authority to give direction to ONGC Regional Office, Mumbai to scrutinize the documents properly and **M/s. Geruda Support Services Pvt. Ltd.** may please be asked to submit the following documents to support their experience certificates before placement of NOA/Contract.

- Copies of Invoices raised by **M/s. Geruda Support Services Pvt. Ltd.** against **M/s. Jagson International** and payment received by **M/s. Jagson International** with bank statement for Catering and Housekeeping.

- Copy of the TDS deducted as per form AS26.
- The service Tax return (ST-3) for above period alongwith Copies of Service Tax Challans.

We are very much sure and confident that **M/s. Geruda Support Services Pvt. Ltd.** will not be able to provide the above mentioned documents in support to their claim as they have submitted false satisfactory completion letter. As mentioned in our earlier letter the Rig was de hired by ONGC during this period, and no catering service was rendered by **M/s. Geruda Support Services Pvt. Ltd.**

We feel very unfortunate even after sounding our concern about the good catering service for our employees working in offshore, who are staying away from their families and toiling day and night to increase the production of Oil And Gas for ONGC, management is lagging in its concern. Timely action will save both ONGC and Union for three years having bad catering service from such an incompetent caterer, which have experienced in the past also.


Your esteemed authority will definitely gauge the seriousness of our letter and it is anticipated prompt action will be taken against the **M/s. Geruda Support Services Pvt. Ltd.** to avoid future complications. Till then we request your authority not to finalize the catering tender.
