Subject: Reimbursement of Crane Operation License fees or to appoint an agency to revalidate their Crane Operation License i.e. API-RP-2D, Gr. I.

Respected Sir,

This is to inform you that we have appointed Jr. Asstt. Operators (Heavy Vehicle) i.e. Crane Operators to operate the cranes in offshore installations. One of the condition was they should possess API-RP-2D, Gr. I certificate to operate the cranes above 35 tones to be appointed as Crane Operator. This condition/qualification was not made compulsory previously.

Unfortunately it was decided unilaterally without having discussed in R&P bilateral meeting with recognized unions, neither validation-revalidation criteria was incorporated during recruitment. It has been brought to our notice that R&P section is asking, giving message to these Jr. Asstt. Operators (Heavy Vehicle) i.e. Crane Operators to revalidate their API-RP-2D, Gr. I certificate as it is issued for one year. This only surfaces that R&P is so fickle.


To revalidate the certificate individual has to spend around Rs. 8000/- (Rupees Eight Thousand only) every year. When it is requirement of management, we request your authority to kindly reimburse the fees paid by them for revalidation every year. Without revalidation of the above certificate their probation will not be cleared is also an additional clause, which may please be noted.

In fact certification of Rig In charge / OIM of platform, should be validation enough, otherwise we are devaluing his PAR. to operate the crane. We will appreciate in line with driving license, management may please take up the issue with the validating authorities and make it for 15 years.
