## **Subject : Procurement of Hand Gloves.**

Respected Sir,

It has been brought to our notice by our crew members that no cotton hand gloves are available on all rigs. The rate contract was fixed with **M/s. Kiritkumar Co.** in the last year for supplying **1,25,000 (One lakh twenty five thousand)** pairs but unfortunately they could supply only **30,000 pairs** till day. Balance pairs of **90,000 (Ninety thousand)** are not yet supplied even after lapses of one year and our vigorous follow up.

As you are aware cotton hand gloves are required every day for handling the material as well as when crew is doing maintenance and drilling work. It is need not to mentioned or elaborated how hand gloves are important on Rig or Platforms. To meet the requirement of hand gloves on rigs, individual rigs are purchasing hand gloves at double rate from impress money. It is a mockery of our safety policies.

The questions are arising in our mind that why action has not been taken even after lapses of one year to terminate the contract of **M/s. Kiritkumar Co.** It seems the issue has been taken very casually by concern MM department which is shameful on our part.

Your esteemed authority is requested to initiate the action on the concerned authorities and action to procedure the hand gloves so that crew on the rig can work peacefully on rig so that maximum productivity can be achieved.

Hope you will not compel us to go on direct action for supply of safety atoms which is the responsibility of concern department.
