Respected Sir,

This has reference to your letter no. MR/RO/SEE/71728/2017 dtd. 8/9/2017 addressed to Smt. Nalini Anil Mhatre whose husband Late Anil Dhanaji Mhatre, who was designated as Sr. High Pressure Welder, CPF no. 71728 met with an accident on Rig Sagar Kiran and died on 11th May 2015.

As Shri. Anil D. Mhatre died on duty on Rig Sagar Kiran, his wife Smt. Nalini Anil Mhatre applied for employment in ONGC for her son Shri. Abhineet Anil Mhatre, who is a engineering graduate i.e. B. E. (Mech). The application of his wife and bio data of her son is enclosed herewith for your perusal please.


By going through letter issued by our office it is mention at point No.1 that "**employment assistance is only granted to the dependent of an employee who dies in an accident on duty**". At the same time at point No. 4 she has been advised to apply against the posts as & when vacancies are notified and his candidature shall be considered along with other candidates. The above two clauses are contradicting each other, or the issuing authority has missed out on the fact that, the said case is an accidental death whole on duty.

As Shri. Anil D. Mhatre died on duty at Rig Sagar Kiran, his son who is engineering graduate is entitle to get employment assistance in ONGC. Please find the necessary documents suporting the cause of death.

Your esteemed authority is requested to kindly look into the matter, his case may please be processed and be referred to concern authority in head quarter for further action.
