This has reference to the letter dtd. 12/10/2017 received from crew members of BPB platform regarding their ending issues. All the issues are detailed in their letter. Please find enclosed the copy of the same for your perusal and necessary action.


Following are the issues raised by the crew for immediate action.

- Mirror lights above wash basin and table lighting fixtures are rusted and in damaged condition required to be replaced.
- There is shortage of Blanket covers, Mattresses. Inmates are facing problem due to non availability of above mentioned items. Most of the blankets covers and mattresses are old and are not been replaced in last 7-8 years.
- Fiber made mobile toilets are to be provided at all unman installations as well-head team members find it difficult to attend nature call. This problem of toilets is prevailing almost on all unmanned platforms.
- Maintenance is required for Gym equipment's, request is already sent but no action has been taken till date.
- Bed available on unmanned platform are rusted and in delapiledted conditions require replacement.

- For room lockers survey was conducted for requirement but crew is unaware regarding the action taken by concern authority to provide lockers.
- New table tennis table required at Ping Pong room BLQ-2 as old one has been condemned.
- Regarding PRP we had meeting in your esteemed office. Required help of I/c, HR/ER to resolve the issue.
- I/c, HR/ER's visit to BPB must be arranged for interaction with the crew members.

Your esteemed authority is requested to kindly give direction to concerned department and authorities to resolve the issues and meeting of union representatives in your presence be called to apprise the status of these issues at the earliest.
