Sub: "LED Bulbs" connection in Bunkhouse at unmanned platforms of SHP, MH-Asset.

Respect Sir,

We are in a receipt of a complaint letter from SHP, MH Asset for giving connection of "**LED BULBS**" in the bunkhouse. This is our second letter on the above issue, first letter was issued on 17/10/2017, till date crew have not received any information in this regard or the action taken for procurement of "**LED BULBS**" connecting is still a distant issue. Please find enclosed the copy of the same for your perusal.

Your authority must be aware that due to operational problems or non availability of helicopter service also to complete the unfinished work and if they have to continue beyond chopper scheduling, employees are compelled to stay at unmanned platforms very frequently.

It is very surprising and painful to note urgency is not felt that there is no light in the Bunkhouse and crew member has to stay in dark all through the night, this situation prevails almost on all the unmanned platforms. Spending whole night without light in a Bunkhouse is really a matter of serious concern, most unsafe could lead to fetal accident.

Moreover crew members have suggested to take electricity supply from solar Panel which are installed at unmanned platforms. The expenditure for connections and procurement of "**LED BULBS**" is very meager which will reduce the uncomfortable situation for those have to stay back during night on unmanned platforms. Kindly note that non-availability of light on unmanned platforms is against safety norms.

Your esteemed authority is requested to kindly look into that matter and action may please be initiated on priority for giving electric connection in Bunkhouses on all unmanned platforms, procurement of "LED BULBS" may please be expedited.
