Subject : Bypassing of "Measurement column", rises all possibilities of Dungarees not stitched to the right sizes.

Respected Sir,

This has reference to the order placed for supplying Fire Retardant Dungaree with "**M/s Shree Deepak Export**" vide office order no. DLI/CMM/PPE/FROVERALL/ZA1SC15002/8030000386 dtd. 31/01/2017. Please find enclosed the copy of order for your perusal.

We would like to bring to your kind notice that there is no mention of column "Measurement" in the order which was existing in the order placed for cotton dungarees on 31/8/2016 vide order no. HQ/CMM/RC/CSE-Cotton/04/ 2015-16/8030000368. Please find attached copy for your perusal, on page no. 2, at serial EE, Measurement column is written, where it has been clearly mentioned the stitched cotton overall as per actual measurement of employee located at different work centres of ONGC to be obtained as per following methodology which is on page no. 3.

Whereas there is no mention of this column i.e. measurement in the order placed for "Fire Retardant Dungarees". Now it is uncertain whether supplier will take the actual measurements of employees located at different work centres of ONGC or not. We feel this being hand in gloves of some officers to fever the supplier. We attribute the above claim as this ambiguity was brought to the notice of concern authorities in MM Department in New Delhi by Mumbai Region, but has fall on deaf ears.



As usual employees will not get the dungarees as per their measurement and will not be suitable to wear in offshore. The order placed is more than 22 crores, additionally administration charges, the financial implication and all the exercise will be waste. We are already having very bad experience of Fire Retardant Dungarees which was supplied earlier, neither dungarees were as per employees measurement nor were suitable to use at work place i.e. in offshore and onshore area.

Your esteemed authority is requested to kindly give directives to the concern department to amend the order before it becomes a wasteful exercise.
