Respected Sir,

This has reference to our earlier letter ref. no. ONGC/KS/066/2017 Dtd. 19/06/2017 vide which we had declared action program for conducting of MOU-2004 meeting at the earliest, which has been delayed abnormally. The last meeting was conducted on 01/11/2017 in Dehradun where all recognised unions had almost arrived at final conclusion. Now almost three months are over and affected category is pressurising hard for early meeting and an amicable solution.

It is pertinent to mention here that without finalising the issue of MOU-2004 we cannot go for meeting of R&P as decision of MOU-2004 has to be incorporated in new R&P, which will be followed by further recruitment and moreover this also is effecting meetings towards pay revision which has fallen due from 01/01/2017.

In the letter mentioned above we had postponed our action program vide our letter no. ONGC/KS/070/2017 Dtd. 30/06/2017 on request of Management as meeting was called on 11/07/2017. Now we are compelled to go with our action program as meeting of MOU-2004 is not being called.


