
OFFICE ORDER

In supersession of Office Order No.MR/RO/Estt./CPP/2007 dated March 13, 2007, CPP charges during normal hours for the purpose of reimbursement to officials on tour to and fro from Kochi shall stand revised as under with immediate effect:

Sl.No.	Places	Existing CPP charges	Revised CPP charges
01	Taxi charge from Airport to Cochin Shipyard Ltd. (CSL) / Kochi City / CPP or vice-versa	On actual basis subject to max. of Rs.500/-	On actual basis subject to max .of Rs.1000/-
02	Ernakulam Junction Rly. Station / Central Bus stand to CSL / City / CPP or vice-versa	On actual basis subject to max. of Rs.200/-	On actual basis subject to max. of Rs.400/-
03	Ernakulam Town Rly. station to CSL / City / CPP or vice-versa	On actual basis subject to max. of Rs.250/-	On actual basis subject to max. of Rs.500/-

2. The charges during night journey i.e. between 23.00 hrs to 05.00 hrs shall be paid 25% extra over and above the admissible rates.
3. The revised CPP charges will be effective from the date of issue of the order and shall be valid for a period of three years i.e. up to October 2016.
4. However, past cases already settled shall not be re-opened.
