Subject : Notice concerning indefinite "Hunger Strike" from 4th Sept'2018 as no details are submitted by concerned OIMs/MMs regarding non availment of C/Off in offshore.

Respected Sir,

This is in reference to our earlier letter no. **ONGC/KS/65/2017 Dtd. 13/06/2017** regarding compensatory off to the offshore going employees addressed to Director Offshore. Meeting was held in this regard with ED-Chief ER along with GM-I/C corporate IR, on 16/02/2018 in Mumbai.

Accordingly instructions were given by ED-Chief ER's office through DGM-I/C Corporate Policy to DGM I/C IR, Mumbai Region. After receiving instructions DGM- I/C IR, issued a letter on 17/02/2018 to all incharges of HR/ER of MH Asset, N&H Asset & B&S Asset, followed by three reminders were also sent to concern assets, but has fallen to deaf ears. Please find enclosed the copy of the same for your perusal.

It is very unfortunate to note that till date they have not received the lists of employees who could not avail their C/Off against the overtime performed by them for working beyond 12 hours as well as beyond fourteen (14) days. It is pertinent to mention that almost 6 months have passed but concern sections are not serious about the issue. We have viewed it very seriously as after issuing our letter almost 1 year and two months are over.

We firmly believe that we have displayed unnessery patience, to resolve the issue the situation has compelled Union us to go for action. Accordingly we are declaring indefinite "**Hunger Strike**" from **4th September'2018** commencing **from 07:00 Hrs.** on all offshore installations as well as Base offices including Nhava, Panvel and Uran plant. Kindly note that all employees will perform their normal duty without taking food.

Yours esteemed authority is requested to kindly look into the matter as very casual approach is the order of the day by concern authorities in WOU related to the issue.
