MINUTES OF THE MEETING HELD BEFORE THE RETURNING OFFICER & DY. CHIEF LABOUR COMMISSIONER (CENTRAL) MUMBAI ON 17.05.2018 TO DISCUSS & FINALISE THE DATE & THE CALENDAR OF EVENTS in respect of SECRET BALLOT ELECTION to be held in ONGC Ltd.,

The Govt. of India, Ministry of Labour & Employment has appointed Dy. Chief Labour Commissioner(C), Mumbai as Returning Officer vide letter No. 32(53)/2016/Vfn dated 04.05.2018 for conducting Secret Ballot Election in Oil & Natural Gas corporation Ltd.,(WOU) for ascertaining the membership of Unions operating therein.

Accordingly a meeting was convened on 17.05.2018 at 10:30 hrs. associating all the four **Unions and the Management.** The Management representatives as well as representatives of the four 4 unions of ONGC were present.





The issue regarding separate counting of votes in respect of Hazira was raised by ONGC Mazdoor Sangh, Petroleum Employees Union. 
