Respected Sir,

This has reference to the circular no. **WOU/RO/HR/ER/ERP/2016 dtd. 1st Dec. 2016** regarding CPP charges to the employees doing on/off duty to "**Western Offshore Unit**". This circular was issued on 1st Dec. 2016 and was effective from 1st Dec. 2016 to 30th Nov. 2019 for three years.

The period of three years is expiring on 30th Nov. 2019. It is pertinent to mention here that in all other regions the period of revised CPP charges is only for **two years**, whereas only in "**Western Offshore Unit**" it has been decided for **three years**.

Your esteemed authority is requested to kindly give direction to the concerned authority for revision of CPP charges and period for revised CPP charges should be of only **two years as other regions**.
