**Sub: Discontinuation of Hotel Ginger for non-executives quarantine  
in the hotel doing on-off duty to offshore**

Respected Sir,

This has reference to our letter no. ONGC/KS/36/2020 Dtd. 25/11/2020 regarding the complaints of **Hotel Ginger**. Accordingly visit to **Hotel Ginger** and **Hotel Lemon Tree** was arranged by your authority to ascertain the issues raised in the letter. Please find enclosed the copy of our letter mentioned above for your perusal.

The team of four members including undersigned and Shri. Parag Kadam, Vice president, Karmachari Sanghatana, Shri. Amit Dhulap and Shri. Suboth Kujur, CM I/c Hospitality visited **Hotel Ginger** and **Hotel Lemon Tree** on 28<sup>th</sup> Nov 2020. The area of the rooms available in Hotel Ginger is too small, a person cannot move freely in room as space available is too inadequate (Only 210 Sq. feet). There is no chance of any exercise in the room. Even only walking exercise is also not possible in room.

Comparing to **Hotel Ginger**, rooms are big in **Hotel Lemon Tree** (270 Sq. feet area) where enough space is available for exercise and as length of the room is also sufficient for walking exercise. **Hotel Lemon Tree** is having spacious restaurant and Kitchen also. It is very difficult to stay in Hotel Ginger for 7 to 8 days without any exercise in such a congested room. Non executives staying in hotel have strong reservation. As already mentioned in our earlier letter difference between the tariffs is **only 600/-** per day which is meager amount compare to difficulties facing by employees to accommodate themselves in a small room for 24 hrs quarantine for 8 to 10 days. We met personally to our crew members in **Hotel Lemon Tree** where they have reported regarding quality and quantity of food is satisfactory. The rooms/ bathrooms were also found hygienic.



Your esteemed authority is requested to give direction to concerned authority that non-executives be allotted room in **Hotel Lemon Tree** only as contract of **Hotel Ginger** is expiring on **31<sup>st</sup> Dec 2020**. Simultaneously action for empaneling the new hotels may please be initiated at the earliest so that we can send our non-executives in newly impaneled hotels from 1<sup>st</sup> Jan. 2021. Precaution must be taken while selecting the impaneled hotels that rooms should be of at least 275 to 300 sq. feet.
