**Respected Sir/Madam,**

This has reference to above referred Strike Notices tendered in accordance with the sub section (1) of section 22 of the Industrial Dispute Act, 1947 wherein, the General Secretaries of recognized unions of Oil and Natural Gas Corporation Limited proposed to call agitation programme commenced w.e.f. 10/02/2020 along with upcoming one day strike on 20/02/2020, the same was deferred by one week.

In this regard, it is to state that a meeting was convened on 21/02/2020 and extended to 22/02/2020 in order to resolve the issues mentioned in strike notice, wherein all issues were discussed in positive direction.

Finally ED-Chief ER has again called the meeting in the first week of March 2020 and requested all Recognized Unions not to resort any strike till the next meeting. **Therefore, in consultation with all Recognised General Secretaries the Co-ordination Committee has decided to defer its upcoming agitation programme w.e.f. 17/02/2020 along with one day strike till second week of March 2020 . We are hopeful that the positive negotiations are again resumed and demands are met amicably in the interest of organisation and its unionised category of employees so that Industrial Peace & Harmony in the Organization is maintained.**
