This is in reference to the complaints received from crew members performing on/off duty in offshore Chartered Rigs, regarding non receipts of **"Toiletry Kits"**. The employees from Logging, Chemistry, Cementing, Reservoir, Well Services sections etc. are working on chartered rigs, whereas employees of Reservoir and Well Services section who are working interminantly on chartered rigs are regularly receiving **"Toiletry Kits"** from their respective ONGC rigs and platforms in the offshore.

This issue has been discussed number of times with your esteemed authority along with ED-HDS and ED-Deep Water for purchasing **"Toiletry Kit"** by initiating separate proposal. Till date no action has been taken to resolve the issue, as a result employees working in offshore including Executives & Non executives of logging, cementing and chemistry section are deprived of getting **"Toiletry Kits"**. Employees working in Reservoir and Well Service Section are receiving **"Toiletry Kit"** regularly. Offcourse this was also implemented with your intervention and continuous follow up by our union only. The issue is pending since long and still it is unresolved.




