We are in receipt of letter mentioning to provide some facilities for the employees working at our various terminals of Trombay Terminal, BPCL, HPCL, JD & JNPT.

There are basic facilities required at terminal like drinking water, Tea, Snacks first aid kit, safety Torch etc. other requirements mentioned are for smooth operation of terminals which in fact working staff should not have requested these things should be always available. We are operating our above mentioned terminals in three shifts. We have raised these issues in our bilateral meeting regularly. Earlier number of employees were less but during last 8 to 10 years we have recruited technicians for Trombay terminal as per our long pending demand.

Following are the requirement of the terminal and we expect immediate action for procurement and proving facilities.

Trombay Terminal –

- Locker facility for newly recruited employees,
- Adequate space for dining be provided,
- Walkie-Talkies at control room
- safety Torch
- Tea and Snacks arrangement for general shift employees.

BPCL Terminal –

- Safety Torch
- First Aid Kit
- Emergency communication set (VHF) land line available is provide by BPCL
- Foot operated sanitizer stand
- No internet connection is available. Provision of internet facility be made on priority

- Arrangement for drinking water needs to be done at war footing in Jawahar Deep. Action may please be initiated for installation of “**Aqua Guard**”,
- Locker facility for the employees working at terminal,
- Foot operated sanitizer stand.

HPCL Terminal –


- There is no arrangement for drinking water at HPCL metering station, immediate action may please be initiated to install “**Aqua Guard**”
- safety Torch
- Emergency communication set (VHF)
- Only one land line is available for communication which is provide by HPCL.
- First Aid kit
- Foot operated sanitisation stand
- No internet connection is available at terminal. Action may please be initiated to provide internet connection.

JNPT Terminal –

- First Aid Kit
- safety Torch
- No arrangement for drinking water at JNPT terminal immediate action may please be taken to install “**Aqua Guard**”
- Locker facility for employees working at terminal. Employees are working in three shifts.
- There is no bathroom and wash room neither water storage tank is available. These are basic requirement at the workplace. Employees are facing problems when NMCGM cuts the water supply.

Your esteemed authority is requested to kindly look into the matter and dedicated officer may please be appointed to resolve these basic and operational required issues. By providing above mentioned facilities, operations at all these terminals can be smoother and our employees working in three shifts will be relieved from mental and physical stress.
