**Sub: Request to sanction the amount of Rs. 644194/- from Sahayog Trust to Smt. Manisha Vijay Chachad Wife of Late Shri. Vijay Chachad a Contract employee.**

Respected Sir

We are in a receipt of request application from **Smt. Manisha Vijay Chachad** wife of Late **Shri. Vijay Chachad** who was a contract employee, working under the contract of **M/s. Moosa Services Co.** in Vasudhara Bhavan. During the treatment given in the hospital he expired on 18<sup>th</sup> June 2020. Please find attached the copy of her request letter for your perusal.

Shri. Vijay Chachad was working under the **M/s. Moosa Services Co.** prior to this he was working under the contract of **M/s. Worli Xerox** who had purchased the Mediclaim Policy from "**Religare Health Insurance**". After admitting Shri Vijay Chachad in hospital by his family, Hospital authority asked their family the history of the patient where it was revealed that he was suffering from pre-existing disease sickness of Seizure Disorder (Fits) from last 15 years. As a result their family has to pay the total medical bill in Hospital as hospital authority refused to accept their medical Policy.

As your authority is aware contract employees are drawing very meagre salary and to pay amount of **Rs. 644194/- (Rupees Six Lac Forty-Four Thousand One Hundred and ninety-Four only)** was beyond their capacity. Presently they have borrowed the amount from their relatives which they are bound to return them. The untimely death of Shri. Vijay Chachad has created multiple problems in their family. Moreover, he has left behind two children's, one son and one daughter.

The main purpose/aim of establishment of **Sahayog Trust** is to help the contract labours as they have no income resources other than their meagre salary. By denying them the claim of medical bills of hospitalization incurred by them is defeating the purpose of Sahayog Trust. It is pertinent to mention here that his Mediclaim Policy was not accepted by the hospital authority which has compelled the family of Shri. Vijay Chachad to borrow the huge amount from their relatives.


