Sub: Request to accord special sanction for the Air Journey incurred while performing offshore duty by Shri. Abrar Ahmed, Field operator

Respected Sir,

We are in receipt of appeal letter from **Shri. Abrar Ahmed, CPF No. 96476, Field Operator**, working in Rig Sagar Vijay, presently transferred to Rig Sagar Ratna.

During the pandemic of Covid-19 employees have worked in offshore for more than 45 days to 75 days continuously. Field operators in Mumbai region were no exception to the circumstances. Accordingly Shri. Abrar Ahmed, field operator has performed his duty in four schedules in offshore. During this period, he was tested Covid-19 positive and had undergone treatment in S L Raheja Hospital for 6 days and was then quarantined at his native place Siwan, Bihar.

As no train tickets were available Shri. Abrar Ahmed was compelled to buy air tickets to go to his native place in Bihar. It is pertinent to mention here that Shri. Abrar Ahmed is the only field operator out of 13 performing duty from his native place Bihar. Recently we have revised the salary package of field operators with no other facilities as extended to regular employees.

Your esteemed authority is requested to kindly accord special approval for the reimbursement of air tickets of the duty performed to offshore by Shri. Abrar Ahmed.

Subject: Request application for reimbursement of Air Tickets for attending duty in offshore during pandemic of covid-19.

Respected Sir,

I, the undersigned am working as field operator on rig Sagar Vijay. I joined ONGC on 23rd November 2001 and was posted on rig Sagar Vijay. Since then I am doing my regular on/off duty to offshore.

Before lockdown I sent on rig on 1st Feb 2020 and de-boarded on 19th Feb 2020. Again after availing C-off I went on rig on 4th March 2020 and de-boarded on 15th March 2020.

As there was no train tickets available I travelled by Air to attend the duty and went to my native place on 19th Feb 2021 by train AC-III tier.

Sir, I performed my first duty during pandemic of Covid-19 in the month of May 2020. I went on rig on 15th May 2020 and de-boarded on 26th June 2020. I came to Mumbai from my native place, Sivan-Bihar by train and went to Sivan-Bihar by train only.

My second trip was on 3rd Oct. 2020 to 19th November 2020 on rig. As I was found Covid-19 positive I was brought back to base and admitted in Raheja Hospital. I was given discharged on 24th November 2020. I was quarantined in the Hotel in Mumbai for two days on 27th November 2020. I went to my native place by Bus. **The approval was given by competent authority for journey and my TA bill was sanctioned.**

My fifth tenure for field operator was expired on 15th Feb 2021. I again came to Mumbai on 17th Feb 2021 to complete my formalities for next term. On 20th Feb my Sixth term was renewed and accordingly I was quarantined on 25th Feb 2021 and was sent to Hotel Lemon Tree. After quarantined I was sent on Sagar Bhushan rig on 5th March 2021. As my rig Sagar Vijay is in for dry docking from Jan 2021.

As mentioned above to join my duty I came to Mumbai by Air as no train tickets were available. This has been already informed to controlling officer and Rig manager. After performing my duty on rig I was de-boarded on 6th April 2021. As there was no train tickets available and no staying arrangement in Mumbai I went to my native place by Air on 8th April 2020.

Ship Sagar Vijay is in dry docking from Jan 2021 and due to recent cyclone (Taukte) equipment's on rig Sagar Bhushan are damaged so I have been transferred to Rig Sagar Ratna.

Sir, I am doing my duty to offshore very sincerely and dedicatedly, I have completed my three trips during lockdown period.

At the same time as I found Covid-19 positive on rig I was admitted in Raheja Hospital for 5 days and was kept for 28 days in quarantine. I am the only field operator doing on/off duty from my native place Sivan-Bihar.


Your esteemed authority is requested kindly accord the special sanction for my Air Journey and train journey of AC-III tier as mentioned below as no train tickets were available.

The Rig Incharge Controlling office were giving me continuous phone call to attend the duty. I am submitting my T.A bills for your proposal. Sir we the field operators are drawing very meagre salary and we have completed 20 years' service in ONGC.
