Subject: Inappropriate handing over of stock to newly recruited storekeepers, matter of serious concern and objectionable too.

Respected Sir,

We are in a receipt of representation from **Shri. Padmakar D. Wadaskar**, CPF no. 136815, Jr. Asstt (MM) Joined ONGC on 12th Sept. 2019. He has explained everything in his representation addressed to your esteemed authority. Please find enclosed the copy of his representation for your perusal.

We understand from his representation that without tallying stocks are handed over to Shri. Padmakar Wadaskar from the employees who are superannuating. No proper procedure has been followed while handing over the stock to Shri. Wadaskar who has completed just one year and without giving him any training neither any experienced person was asked to assist him. It would have been more appropriate that some experienced authority should have been handed over the stock of retiring employees. Such high handed approach towards new recruits is a matter of serious concern.

Its pertinent to mention here that, may be due to the nature of assignment, that even during lock down period they have attended duty every day at Nhava Supply Base and kept his stock clear when they were required to commute from Ulve village which is around 10 kms away from NSB.

All these newly recruited store keepers were compelled to take the stock by your authority. There are very old items in the stock which were never tallied by MM department earlier. There are in total four newly recruited store keepers who are inexperienced. The haste with which these stocks were handed over to these inexperienced store keepers is highly objectionable. **Kindly note that they should not be held responsible if there is any shortage in the stocks accepted by them.**


