Subject: Arrears of overtime to "Field Operators", who performed duty in offshore in reference to the circular of pay revision.

Respected Sir,

This has reference to the circular no. DDN/CORP-ER/Estt- Policy/2019/ TBFO/502392 dtd. 10/04/2021 regarding pay revision of "Field Operators". The notional basic pay of Field Operators pay was enhanced from Rs. 12000/to Rs. 22500/-. Accordingly the "Signing Bonus" of equal to three basic pay was released to the Field Operator considering new basic pay of Rs. 22500/-.

All these Field Operators have performed their duty in offshore during the pandemic of COVID 19. They have performed duty continuously for around 75 days, 60 days and 35 days respectively in their first, second and third shift.

Unfortunately, they are yet to be paid their overtime arrears as their notional basic is enhanced from Rs. 12000/- to Rs. 22500/-. It is pertinent to mention here that regular employees have already received their overtime arrears in the month of Dec. 2020 along with their pay revision arrears. It has been confirmed that there are around 550 Field Workers in Rajahmundry and Karaikal who have received arrears payment of overtime.

Your esteemed authority is requested to kindly give direction to the concerned authority for releasing the overtime arrears payment of "Field Operators" as it is already delayed by more than one year.
