**Subject : Non - filling of accident report of fire on Rig Sagar Shakti happened on 19/07/2022 in Engine Room (i.e. of Electrical Panel).**

Respected Sir,

This has reference to the fire accident took place on rig Sagar Shakti on 19/07/2022 in "Engine Room". Following three employees including on contract labour were injured in the accident.

1. Shri. Saurabh Ahuja AEE (Elect) 137699
2. Shri. Abhishek Burase Jr. Roustabout 136612
3. Shri. Abbas Contract Labour

The incident of fire happened at around 12.45 hrs. in the night where electric panel in the engine room caught fire. This incident was informed by **Shri. Navin Pandey, Mech R/A** contract employee to **Shri. Abhishek Burase Jr. R/A**. He tried his level best to extinguish the fire by using fire extinguisher but could not. Then he called the electrical engineer **Shri. Saurabh Ahuja** who switched off the Electric Panel supply first and they both along with contract employee extinguished the fire.

While rushing to engine room in hurry after receiving call from **Shri. Abhishek Burase, Shri. Saurabh Ahuja** fell down and injured to his knee. **Shri. Abbas** a contractual Mech Roustabout also got injured below his knee.

All these three employees including contract labour were brought to base in Crew Change Chopper and were admitted in Nanavati Hospital. As no concerned doctor was available in the Nanavati Hospital, **Shri. Abhishek Burase** was advised to take treatment in Kalyan where he is residing. Both our above mentioned employees are under treatment now. Contract labour **Shri. Abbas** is being given treatment by his contractor presently.

Very unfortunate to note that today fourteen (14) days have completed but no "**Accident Report**" has been filled up by the concerned authority on rig Sagar Shakti neither instructions have been given by Rig Manager to the concerned officer.

It is painful to note that it is a regular practice and authorities are trying to hide such incidents, reasons best known to them. We have viewed very seriously the incident and demanding immediate inquiry by your esteemed authority. Simultaneously your esteemed authority is requested to direct the concerned Rig Manager to fill up the "**Accident Report**" immediately.

Hope your authority will look into the matter very seriously and will issue a proper office order to all rig incharges so that such incidents will not repeat in future.
