The Gymnasium with minimum facility was provided on B-193 in the year 2013. As mentioned in the letter the daily average POB at platform is 90 and provided Gym equipment's are inadequate as a result interested employees are deprived from doing exercise for their physical fitness in the gymnasium. Please find attached the copy of letter for your perusal.

The detail list of Gymnasium equipment's required on B-193 was forwarded to concerned authority at base by **Shri. M. K. Karunakaran, DGM (P)- OIM-B-193**. So also the list of Gym equipment's provided in the year 2013 was also enclosed with the mentioned letter.

Recently total seven trade mills were sent on **platforms BPA (2), BPB (2), Tapti Field (2), D-1 (1)** and distributed as per the figure mentioned in bracket. Unfortunately not a single trade mill is sent on B-193 platform. There is immense frustration and wide spread unrest among the employees on platform B-193, even when the need is aptly justified and their neighbor platforms are getting it, a feeling of secondary treatment is fast creeping in.

Your esteemed authority is requested to kindly look into the matter and give direction to concerned authority for initiating proposal for Gym equipment's as mentioned in the letter.
