**Subject: Sincere gratitude for securing our jobs and continue our service on Ambulances at ONGC Uran Plant and other locations in Mumbai Region.**

Respected Sir,

We the contractual staff working as drivers and cleaners on Ambulance at ONGC Uran Plant and other locations in MR. The old contract (M/s Lifejet Cardiac Ambulance Services) of Ambulance expired on 13.01.2022, with which we were working and the new contract has been awarded to the contractor (M/s Gurunanak Travels). The new contractor had strongly planned to replace the old Ambulance staff (all of us) with his new staff. But our union strongly opposed this action of contractor and demanded to continue with the previous Ambulance staff. But the contractor was not agreeing the proposal. The contractor forcefully tried to deploy on the 05 Ambulances with few new staffs at various locations of ONGC. Due to this action of contractor the Local Secretaries of union strongly opposed & approached to the ONGC management at all respective work centers and especially the General Secretary approached to the Incharge Surface Logistics and GGM-HRO at Head office, MR for denying entry to the Ambulance in ONGC premises till this issue is resolved. During this period (03 Days) the union did not allowed single Ambulance of contractor inside the ONGC premises. The contractor has to agree with union's demand.

The union fought for our jobs. This was very crucial point for us as our employment was at risk. But **ONGC Karmachari Sanghatna** stood behind us strongly hence the contractor went to back foot and agreed to continue with previous staff.

The special efforts were made by **Shri. Ujjesh Tupe** and his team from Uran Plant, **Shri Pramod Mestry** and his team from ONGC Panvel, **Shri Navnath Temkar** from Helibase and **Shri Sandip Gawade** from Nhava under the guidance of **Shri. Pradeep Mayekar**, Gen. Secretary, Karmachari Sanghatna, **Shri. Prakash Dalvi** and **Shri. Parag Kadam**.

Sir we have uttermost confidence in the knowledge you have and ability to take right decision at right time. Your leadership have always benefited to all the staff employees without considering the union which they belong.
