Subject: Unsafe Practice of Casing Lifting followed on Rig Sagar Vijay may cause serious accident on Rig.

Respected Sir,

We are in a receipt of complaint regarding unsafe practice of casing lifting being followed on rig Sagar Vijay, this may cause serious accident on Rig. Please find enclosed the copy of complaint for your perusal and direction to make necessary corrective action.

Previous practice of casing lifting is being forced to bypass by the officials on the Rig. Eventually, both the crane operators of the Rig are compelled to give complaint in writing. Following are the disadvantages due to unsafe practice:

- The height between the Rig floor and Crane Cabin is around 10 to 12 ft. The rig floor view cannot be seen clearly due to the height, between the rig floor and crane cabin.
- On Jack up Rigs, rig floor is seen very clearly, therefor crane operator can operate the crane very safely.
- As the Jack Up Rig is steady, Crane operation on Jack Up rig is comparatively easier than Floater Rig.
- Sometimes casing handling takes more than 12 hours. Continuous crane operation may distract one's mind due to fatigue and stress, which may cause accident on Floater Rig, more over continuous unsafe crane operation causes back and neck pain leading to spondylosis and or multiple medical ailments.
- This issue was discussed with your authority, showing concern your authority had promised that direction will be given to follow the old practice for handling casing lifting which is very safe. This may please not be attributed as crane operators are avoiding work. Moreover, Crane operators are more worried because crew members are working under the crane and on rig floor too, when they are operating cranes.

Your esteemed authority is requested to kindly look into the matter before any accident takes place on the Rig. Simultaneously meeting be arranged with the undersigned along with Rig Manager and Crane Operators in your esteemed office at the earliest to avoid complication and unrest in the near future.
