**Subject : Acute shortage of linen items on BPB platform, B&S Asset.**


Respected Sir,

Due to acute shortage of blanket covers and bed sheets many ONGCians and contractual employees are using blankets without covers which is unhygienic as their relievers are also using the same blankets. Last more than three months they have taking up the issue with the concerned authority but it seems that no action has been initiated for procurement of linen items.

Yours esteemed authority is requested to kindly look into the matter and direction may please be given to concerned authority for initiating the action for procurement of linen items at the earliest.



I wish to inform you that with continuous follow up by The Karmachari Sanghatana recognized Union with the senior management of B&S Asset, linen items were provided in the year 2021-22. Only by then limited number of Linen items were distributed during that time to ONGCian and some contractors.

Now people are facing acute shortage linen items like Blanket covers, Bed sheet etc. Many contractors and ONCian now using blanket without blanket covers which are causing hygiene issues as their relievers and others also using same blanket.

We discussed the issue with OIM BPB two months ago but he has been unable to solve the issue till date. Hence I hereby request you to look into the matter as earliest for providing linen items in sufficient numbers.
