Subject: Life/death threat given by sub-contractor Shri. Deeapk Janardan Thali working in canteen of Uran Plant a matter of serious concern and complaints regarding inferior quality of food and poor service.

Respected sir,

This has reference to the canteen contract awarded to M/s Prerna Enterprises Pvt. Ltd. to run the canteen in Uran Plant from 1<sup>st</sup> Aug 2022, who has subcontracted the same to 'Shri. Deepak Janardan Thali', how head HR has not objected or stopped the same or is it a permissible clause within the contract terms and condition of the canteen.

From the day of inception of canteen, employees in Uran Plant are continuously giving complaints regarding inferior quality of food and poor service. Very unfortunate to note that no new canteen gadgets are being procured till date by canteen contractor even after completion of 10 months, which aggravates poor quality and service.

Recently canteen committee visited canteen and submitted their report to GM I/c – HR-ER, Uran Palnt. Please find attached the copy of Canteen Committee report for your perusal. Following are the serious observations/complaints by the canteen committee raised in their report.

- No new canteen equipment are procured till date, old canteen gadgets are still used by the contractor even after completion of 10 months from 1st Aug. 2022.
- > Substandard material is used for preparation of food.
- ➤ Non branded food material is used in the canteen though the brands for every items has been specifically mentioned in the new canteen contract.
- ➤ The canteen is subcontracted by the contractor M/s Prerna Enterprises Pvt. Ltd. is a matter of serious concern. Even Uran Plant management is also aware of it.
- Except soda, no soft drinks are available in canteen neither 'A' la carte items are provided till date.

- No tea bags available.
- > No Britannia/Modern brand bread are available, only local brand breads are provided.
- ➤ No ice creams are provided from starting of the contract.
- ➤ Mutton (Goat Meat) is provided only on Sunday which is holiday. Being holiday almost 50% staff remains at home.
- > No slice cakes are provided till date.
- > Old unhygienic tiffin are used which has to be discarded immediately.
- ➤ No fly catchers available in dining area as well as in kitchen area.
- Washrooms are not cleaned and in unhygienic condition.
- Material used for housekeeping is of very poor quality and found local branded.
- > Salt, Pepper & Sugar shaker not available on the dining table.
- > R O filter plant cleaning schedule is not provided by the canteen Manager.
- > There is no data of pest control neither schedule is prepared for the canteen and surrounding area.
- Glasses in the dining area are insufficient quantity.
- No water dispenser is available in the canteen.
- > Veg and non-veg items are kept together in the same deep freezer.
- Chapatti atta was found kept in non-veg frozen compartment.

It is pertinent to mention that the canteen complaints are taken up with management by our union only. Why other collectives and organizations are not lodging any complaint for canteen service is surprising.

Very serious to note that the canteen subcontractor **Shri. Deepak Janardan Thali** has given life/death threat to our union Secretary, **Shri. Balkrishna Kashid** in the plant gate in front of our two office bearers **Shri. Manohar Thali – Vice President** and **Shri. Ujjesh Tupe – Secretary**. While bringing it to your notice we are filing an FIR with the local police being concerned about his safety

**Shri. Deepak Janardan Thali** is mentioning that only **Shri. Balkrishna Kashid** is giving complaints of present canteen contractor regarding substandard quality of food and service. He openly challenges saying that I am managing everyone in Uran Palnt and only office bearers of **Karmachari Sanghatana** are having canteen problems.

Most of the time canteen service is denied to our employees working in shifts and is a frequent phenomenon. Recently canteen menu has been published unilaterally by the canteen contractor without involving recognized union representatives. Why management has not taken objection for publishing menu is surprising and naturally questions the integrity of officer incharge. It seems that Uran Plant management is hand in gloves with the contractor.

We are enclosing herewith, the complaints given by our employees through email. Contractor is **flatly** denying to give the service of some items which are mentioned in the menu.

It has been brought to notice that as per schedule canteen committee meeting should have been conducted every month, which has not been followed by the HR management of Uran Plant. In earlier hygiene survey and inspection, it was brought to the notice of HR that food items with fungus were found in canteen store. Even after our continuous complaints no steps are initiated towards improvement. Only one or two canteen committee meetings has been conducted during last 10 months, but minutes of the meetings are not circulated.

As per Scope Of Work, contractor has to provide three standard breakfast items at a time but contractor is only keeping one breakfast item every time.

There should be proper on line portal for canteen related complaints / suggestions on Uran Intranet. So that every employee will have access to give his observations on the intranet.

There are several complaints of Supervisor Shri. Deepak Janardan Thali regarding his rude behavior with our employees. The supervisor has shown screen shot of messages of Uran Employees Whatsapp group regarding poor service and substandard quality of food to our office bearers Shri. Manohar Thali and Shri. Ujjesh Tupe. A particular employee in the Uran plant who is always instigating contractual employees and regular employees on the Whatsapp group has shared screen shots and Whatsapp chats to the said supervisor and provoked him against our office bearer Shri. Balkrishna Kashid. The Uran Plant management is also aware of that notorious employee who is deliberately creating problems in the Uran Plant.

Monthly hygiene survey of plant canteen and guest house is a part of regular OHC activities. This is being carried out by one doctor and industrial hygienist. During recent hygiene survey conducted by medical team Uran where the same supervisor mischievously made mobile video shooting of **Shri. Balkrishna Kashid** (industrial hygienist) alone (not taken doctor in video shooting inside storage area canteen) It was done purposefully to target **Shri. Balkrishna Kashid.** Such video shooting in the plant premises is illegal and dangerous as far as security and safety of the plant is concern. This video was shown to Mr. Manohar Thali, Vice President KS and told him that he will teach a lesson by assaulting physically Shri. **Balkrishna Kashid** taking help of local gundas.

It is pertinent to mention here that **Shri. Balkrishna Kashid** is travelling by ONGC bus to Uran plant from Kalyan. If anything happens to Shri. Balkrishna Kashid, we may resort to direct action without any notice which may please be noted seriously. We demand entry of **Shri. Deepak Janardan Thali** in the Uran Plant should be stopped immediately, otherwise there will be demonstration in front of your cabin for not stopping entry of **Shri. Deepak Janardan Thali**. Hope to take a serious note of our complaint and act accordingly.

Simultaneously we demand that as there is no improvement in the quality of food and service to the employees' contract of **M/s Prerna Enterprises Pvt Ltd.** should be terminated immediately. A penalty must be imposed as he has not fulfilled the terms and condition of the canteen contract. Accordingly his further canteen bills should not be released till we terminate the contract and black list him too.

A meeting to discuss the serious canteen issues raised in the letter be called at the earliest with the undersigned.

Respected Madam / Sir,

The new contract has been awarded for canteen services to M/s "Prerna Enterprises Pvt Ltd" from 1<sup>st</sup> August 2022. Since starting of contract we have received many complaints from employees regarding the canteen service such as quality of food, fruit and tea as well as overall hygiene. Especially quality of food is very poor. Sometimes the employee's complaint register is not available on counter, it is observed that the some pages of complaint register are torn apart.

Hence the canteen committee Union representatives visited Plant canteen on 05/04/2023 for inspection. The following are the observations of the committee.

## Conclusion:

1. The contractor has not provided many items /equipment's and many of the unbranded / local brand food items are used in the canteen. So that quality of food is not good. (Appendix III of SOW).

2. The contractor is not providing a single item from A la Carte menu (Annexure 1 -

M - A la carte of SOW).

3. The contractor should have brought new items / equipment / utensils required for providing catering services as per SOW (Annexure V). The necessary canteen equipment and utensils etc. are not brought by the new contractor. The contractor is using many old items / equipment / utensils of previous contractor which are not in good condition and are very unhygienic. The use of such items is very harmful for employee's health.

4. Fly catchers not available in Dinning area as well as in Kitchen area.

5. There is too much scope for improvement of hygiene. Washroom are not cleaned and in unhygienic condition.

6. Glasses in Dinning area not sufficient.

- 7. Glass window cleaner, room freshener, liquid soap and naphthalene balls not available in wash room.
- 8. Housekeeping is poor and products used were found local brand.
- 9. Water Dispenser not available in dining area as well as glasses.
- 10. Salt, Pepper & Sugar shaker not available on dining table.
- 11. RO filter Plant cleaning schedule is not provided by Canteen Manager.
- 12. No Data of Pest control in canteen & surrounding area.

13. Chapati atta was kept in non-veg frozen compartment.

14. Canteen Weekly menu implementation is pending from starting of contract it has to be displayed in canteen area as well as Uran Intranet, same is followed in other work center of MR. ī.tc a.

Regular monthly Canteen committee meeting schedule not followed. After many reminders to contractor he is not able to comply terms and condition of contract as per SOW. Hence we have boycotted the canteen committee meeting which is held on 23/03/2023. As per minutes of meeting contractor has agreed to purchase all the equipment's before 30/03/2023. Again contractor has failed to comply all the necessary requirement for proper functioning of canteen.

Considering all above points it is very serious matter of noncompliance and it will adversely effect on the health of employees.

Your esteemed authority is requested to look into the matter seriously and instruct to the proprietors of "Prerna Enterprises Pvt Ltd" (New Contractor) to improve canteen service, the quality of food, hygiene etc and fulfill all the requirement as per SOW to improve canteen services.

#### Minutes of Meeting

A meeting of Canteen committee was held on Thursday 23/03/2023 in the chamber of GM (HR) - I/c HR ER. Following officials were present.

- 1. Dr. J. S. Waghmare, DGM (Medical Services)
- 2. Shri Gaurav Patange, Manager (HR) I/c IR
- 3. Shri Vishant Rana, Sr. HR Exe. I/c H&W
- 4. Shri Vinay Thakur, D.A.(P&A)
- 5. Shri Deepak Thali, Authorized Canteen Representative

After discussion over various issues and concerns, following points are hereby noted:

- 1) Roti Maker & other capital items as per Annexure -V: Even after repeated requests, Roti maker is not yet purchased for standardized quality of Rotis. The list of all items / equipment is mentioned in SOW Annexure - V. To standardize the quality of Rotis, an Industrial Type Roti Maker is required and even after 08 months of commencement of the contract, Industrial Type Roti Maker and few other items/equipment are not yet purchased. The Contractor has agreed to purchase Industrial Type Roti Maker and other items/equipment on/before 31/03/2023. On non-compliance, per day suitable penalty will be imposed.
- 2) Hygiene Survey: During hygiene survey, it was seen and noted that many unbranded / non prescribed brands of raw material was purchased. Also, fungus infected ginger, expired masala oats and loose (unbranded) milk was found. Suitable penalty will be imposed for this lapse.
- 3) Weekly Menu: Weekly menu of food items to be finalized within 02 days and soft copy of the same to be shared with I/c Hospitality. After approval, the menu shall be implemented and adhered we.f 01/04/2022.
- 4) Menu rate chart: The contractor has to display the rate chart having rates of food items as per \$0W. The rate chart should consist of all food item rates mentioned in the contract and should be displayed at the reception which can be read by everyone. For all the customers who are not covered under this scope of work (SOW), contractor may charge extra 70% or Rs. 20/-, whichever is less, in addition to the rates as per table "A- Price List for Supply of Wholesome Food" of Annexure-I mentioned in SOW,

Respected madam writing this mail for your kind attention on the canteen issue which we are facing since yesterday.
