Almost more than two years have completed, but decision is yet to see the light of the day. As already mentioned in our letter there is only one hospital **Dr.Hedgewar Rugnalaya** in **Aurangabad** covering more than seven (7) districts from where number of candidates have been recruited in last ten (10) years. They all are commuting from their respective districts to attend the duty to offshore. No need to elaborate only one hospital is not sufficient to cater the need of medication of our employees doing On/Off duty from surrounding seven districts of Aurangabad. It is pertinent to mention that employees performing duty to offshore are leaving behind their facilities while attending the duty.

The Dhoot Hospital is empanelled by '**Indian Oil Corporation Ltd.**' is having Income Tax exemption certificate also. Whereas presently paneled Hospital Dr.Hedgewar Rugnalaya is not having Income Tax exemption certificate. As mentioned in our letter Dr.Hedgewar Rugnalaya is empanelled in Aurangabad to meet the medical needs in emergency. Empanelment of Dhoot Hospital will be definitely beneficial to our employees and families staying around.

Your esteemed authority is requested to kindly look in to the matter and direction may please be given to medical department for intimation and status of the proposal. The action in this regard is enormously delayed. Also employees residing in an around the Dist. - Aurangabad are pressuring hard for empanelment of additional hospital in the Aurangabad city.


