This has reference to our earlier letter no. ONGC/KS/48/2023 dtd. 15/05/2023 regarding misbehaviour of Shri. Gautam Sharma, EE(P) posted on Heera Platform. We were expecting some action in this regard but unfortunately no action has been initiated as a result Shri. Gautam Shrma is encouraged in provoking our staff members that nothing has happen to me even after your written complaint.

We were expecting transfer of Shri. Gautam Shrma, EE(P) from Heera Platform to some other platform. He must realise that working on Rig/Platform is team work including contract labours and regular employees. We always feel that the contract labour are though underprivileged are integral part of operation and maintenance, should be given proper treatment and respect too. Such arrogance and misbehaviour gives wrong message on the platform. The problems will keep on repeating as he is very arrogant and using abusive language with the subordinates and contract employees also.

The computer and phone provided in the room is for crew members, not for personal use, but he does not allow other crew members to have accesses to it. In our letter we have mentioned that senior aged officers are not allowed lower beds though some officers are having medical problems. Your authority can constitute a committee to verify this facts.

Your esteemed authority is requested to kindly look into the matter and **Shri. Gautam Sharma**, **EE(P)** may please be transferred to some other platform at the same time counselling must be arranged for him so that such incident should not be repeated in future.

Subject: Serious complaint of Shri. Gautam Sharma, EE(P) of his misbehavior with subordinate staff and contractual employees

Respected Sir,

We are in a receipt of serious complaint from Crew members of Heera Platform of Shri. Gautam Sharma EE(P) regarding his misbehavior with the subordinate staff and contract employees also. This complaint is not given first time but there are some incidents in the past also.

The Gally revamping of Heera Platform is in full swing. The present POB on the platform is more than 280. The revamping of Gally is planned to be completed before rainy season. Accordingly line Manager has given permission for two times in day to complete the work.

The work was stopped by Shri. Gautam Sharma EE(P) four times in shift by giving the reason that he is not able to sleep during night time as the work is carried out whole night from last 20 to 25 days. He is the only officer has stopped the work on platform. He behaved very arrogantly with the contractual employees using abusive language. He is neither ready to listen nor giving any co-operation to keep the work continue. He quarreled in very loud voice with our office bearer Shri. Vinod Tawale.

He is not allowing other crew members or contract persons in the room even beds are available. The computer and phone provided in the room is for crew members but not allowed by him to other crew members. Even senior aged officers are not allowed lower bed though some officers are having medical problems.

The atmosphere on platform is polluted by Shri. Gautam Sharma. Also the relations with the other crew members are spoiled by Shri. Gautam Sharma which is damaging work culture on the platform. To get the maximum production, productivity, cohesive atmosphere is required which can be achieved by co-operation.

Your esteemed authority is requested to kindly intervene in the matter and as requested by crew members he may please be transferred from Heera platform. Simultaneously till the end of May 2023 he should not sent on Heera platform. The counselling of **Shri. Gautam Sharma** may also please be arranged so that there will be improvement in his behavior. Kindly note that this should not be treated as complaint if we want to maintain conducive atmosphere on platform. Positive action in the matter will be highly appreciated in the interest of organization as well as crew members.

महोदय,

माननीय साहेब, आपल्याला माहीतच आहे कि,हिरा प्लॅटफॉर्मवर galley revamping चे काम युद्धपातळीवर सुरु आहे. म्हणून anchor ऑफशोरला दिवसा आणि रात्री काम करण्याची परवानगी सगळ्या लाइन मॅनेजर ने दिलेली आहे. pob २८० पेक्षा जास्त सध्या चालू आहे. galley चे काम पावसापूर्वी संपण्यासाठी त्यांना दोन्ही वेळेस परमिट घेऊन काम करण्याची परवानगी दिली आहे.

असे असताना ongcpipline सेकशन मधील अधिकारी गौतम शर्मा EE (P) याने anchor offshore ला रात्री काम करण्याची परवानगी असताना, आतापर्यंत एका शिफ्ट मध्ये चार वेळा galley चे काम त्याला स्वतःला झोप लागत नाही म्हणून थांबवले आहे. गेली २० ते २५ दिवसांपासून काम चालू आहे, ह्या एकट्या माणसानेच आतापर्यंत काम थांबवले आहे आणि कॉन्ट्रॅक्ट च्या लोकांवर अंगावर धावून गेला व त्यांना अपशब्द बोललाहि आहे. भयंकर आवाजामध्ये आणि उगेच आकांडतांडव करत त्यांच्या सोबत भांडला आहे. याच्या अशा वागणुकीमुळे कामगारांनी घाबरून काम थांबवले यामुळे त्यांचा रात्रीचा वेळ आणि दिवस वाया गेलेला आहे. जेव्हा चवथ्यावेळेस anchor supervisor कडून घडलेला प्रकार समजला, तेव्हा गौतम शर्माला विचारले असता आणि समजावले असता, त्याने ना एकूण घेण्याची तैयारी दाखवली ना समजून घेण्याची ना सहकार्य करण्याची उलट तो आमच्याशी (विनोद टवले) आणि कॉन्ट्रॅक्टर supervisor शी परत वाद घालू लागला. परिस्थिती आणि कामाचे गांभीर्य समजून न घेता आमच्यासोबत बाचत होता, चढ्या स्वरात बोलत होता.

यामाणसाची हिच एक तक्रार नसून तो ज्या रूम मध्ये राहतो तिथे देखील रूम चे बेड रिकामे असताणाकोणालाही रूम दिले तरी त्याची असभ्य आणि गैर वर्तुणूक कायम असते. कॉन्ट्रॅक्टर असेल तर रूम मध्ये शिरून न देणे त्यांना अपशब्द बोलणे चालूच असते. तसेच असे पाहण्यात आणि बघण्यात आले आहे कि रूम साठी एक phone आणि एक computer दिला असताना त्यावर आपला हक्क दाखवणे आणि इतर लोकांनी या गोष्टी बापरू नये असे गैर वर्तन हा नेहमीच करत असतो. या गोष्टी घरून आनल्यासारखा करत असतो.

एवढेच नाही तर त्याच्या सेकशनच्या त्याच्यापेक्षा सिनियर सहकारीशी तो दुजाभाव ठेऊन वागतो सिनियर ला मेडिकल अडचण असतानाही हा खालच्या बेड वर झोपतो आणि आपल्या सहकारी ला वर झोपण्यास प्रवृत्त करतो. यांच्या बोरोबरचे दुसरे दोघे incharge पूर्णपणे सहकार्य करतात पण हा माणूस करत नाही. या माणसाचे वागणे बोलणे विचार करण्याची पद्धत परिस्थिती समजून न घेणे सतत वाद घालणे सहकार्य न करणे यामुळे हिरा प्लॅटफॉर्मचे वातावरण खराब होत आहे म्हणून या गौतम शर्माला हिरा मध्ये येण्यासाठी कायमची बंदी घालावी व याच्या आधीपासून व रेगुलर येणारे श्री अशोक कुमार आणि श्री धनंजय भगत यांनाच pipeline services साठी हिरा मध्ये नियमित करावे, अशी आमची नम्र विनंती आहे.
