Every year in the winter and rainy season they have worked without Raincoats and Wind Cheaters. All our Plants are on the paper only. Why concerned authorities have not taken any action for procurement of Raincoats and Wind Cheaters is surprising. It is imperative to give priority to safety and comfort of the employees performing duty day and night on the platform for toiling the production of "Gas and Oil". No need to elaborate the gravity of rain and cold in the offshore during rainy and winter season.

Two months have completed of rainy season and decision of procurement is yet to see the light of day. We expect the decision of "Board Purchase" for good quality of Raincoats and Wind Cheaters from your authority gauging the seriousness of the issue.

Simultaneously we demand to constitute an enquiry committee to find out why these procurement is delayed for four years. It is our responsibility to maintain the conducive atmosphere/environment on the platform.

Your esteemed authority is requested to kindly take a decision for "Board Purchase" of these items i.e. Raincoats and Wind Cheaters so that we can give massage to our all employees that we are here to take care of your safety and health.
