We are in receipt of complaint letter regarding dilapidated condition of sofas and chairs on BPB platform. Please find enclosed the copy of letter for your perusal which is self-explanatory. The same complaint of sofa and chairs to be repaired was brought to the notice of concerned authority on 14.05.2023. Accordingly contract has been awarded to **M/s. Super Marine Manpower** but no action has been taken till date.

Over a period of 6 months and more, condition of sofas and chairs have further worsened. In fact, some sofas and chairs are so bad that they need to be replaced immediately.

The enclosed photographs of sofas and chairs gives exact picture of their existing condition. Crew members including executives are repeatedly giving complaint which have fallen on deaf ears is matter of serious concern as crew members feel that they are deliberately neglected by the management.

Your esteemed authority is requested to kindly intervene in the matter and direction may please be given to the concerned authority for immediate repairing and replacements as needed of sofas and chairs. At the same time action may please be initiated for procurement of new sofas and chairs to replace the **damaged/dilapidated** sofas and chairs at the earliest.




