OIM during period of their overtime claims has been transferred and New OIM has joined in his place who is denying to sign the overtime claims.

The overtime claims of these employees are pending from May- 2022. We would like to bring to your kind notice that refusal of overtime claim performed by them and duly singed by controlling officer is against the provision in the Labour Laws. If the overtime claim is not sanctioned we will have no other alternative but to approach appropriate labour authority for justice i.e. **Regional Labour Commissioner**. This is happening first time and we would like to resolve the issue of payment of overtime within our organisation only which may please be noted.

Your esteemed authority is requested to kindly intervene in the matter and direction may please be given to the concerned authority for sanctioning the overtime claims at the earliest which is their legitimate right. It is almost two years, overtime claims are pending, and further delay may aggravate the matter.
