Subject :- Serious complaint of poor canteen service and substandard quality of vegetables supplied by the canteen contractor, "M/s Prerana Enterprises".

Respected sir,

We are in receipt of a serious complaint by a Canteen committee member who visited on 29.07.2024 of poor canteen service of Uran Plant & substandard quality of vegetables supplied by the canteen contractor "**M/s Prerana Enterprises**". Please find enclosed the copy of complaint of canteen committee member & photographs of rotten vegetables, mouldy groundnuts, in the stock of canteen.

There are continuous complaints of our union regarding the quality of food material, the unhygienic condition of the canteen area, substandard quality of food preparation etc. The attached photographs of rotten vegetables are self-explanatory. Uran canteen is Canteen of "**Maharatna**" Status Company of ONGC & Uran LPG plant is giving huge profit to ONGC from last so many years. Even then we are failed to maintain service and food quality of Uran plant canteen. The Uran plant canteen is subcontracted by the canteen contractor **M/s Prerana Enterprises** & it is a known fact but no serious action has been initiated against the canteen contractor by the concerned authorities is a matter of shame on the part of plant management. No need to mention canteen facility is availed by both, Executives, Non Executives and contractual employees also. As your authority is aware, Uran Plant is run in three shifts where morning shift starts at 07:00 Hrs., evening shift at 13:00 Hrs. & Night shift at 22:00 Hrs.

To attend the morning shift employees have to leave their residence at 05:00 Hrs. & has to wake up at 04:00 Hrs. in the morning. All these employees take their breakfast in the canteen only. We are compelling them to consume unhygienic food because of the casual approach of our concerned authorities in the Uran plant.

Number of times we have given written complaints to blacklisting the canteen contractor but have fallen on deaf ears. Now only alternative left is to demonstrate in front of your office to protest against the lethargic view of management.

To protest against the casual approach against the management following action programme will be observed by our employees in Uran plant.

- **Black batch wearing from 05.08.2024 onwards.**
- **Demonstration during lunch hours in front of "Plant manager's cabin" on 09.08.2024.**



It has been observed that some of food items like peanut, potato, tomato, onion, brinjal etc. were infected with fungus. The raw materials used are of very poor quality. Photos of infected items attached for your kind perusal.

It is to be noted that consumption of infected, unhygienic food items are detrimental to the health of employee's. This may give rise to gastrointestinal disease like food poisoning, diarrhea etc. This is a very serious matter, it is requested to arrange an immediate canteen committee members meeting with the contractor for further action.
