**Subject – Regarding poor catering services at Rig sagar Kiran.**

Sir,

We the staff of Rig sagar Kiran would like to put forward our grievances regarding the poor catering services. Numerous meetings have been held between the rig crew, catering manager, Catering base manager and ONGC management also but no fruitful results have been achieved till date. The last meeting was held between the rig crew, catering manager and DGM (Drilling) on 08.10.2007. The following are the major points which still need to be resolved:

1. The quality of food and fruits provided are very poor.
2. Food is not provided as per the contract and as per the menu.
3. Poor hygienic condition of the mess. No proper cleaning is done and lot of accumulation of garbage all around.
4. Toilet kits and bath soaps are not supplied as per the terms and condition of the contract.
5. Non – availability of food items like fruits, biscuits and snacks from time to time.

It is our earnest request to you to kindly resolve these catering problems at the earliest failing which we would be forced to go on **HUNGER STRIKE FROM 05.11.2007.**
