

Sharma, along with the Chairmen of HPCL, BPCL, IOCL and Director (HR), BPCL**. ONGC had also extended generous financial support for the conference. Since the inception of the Federation, I have been serving as the **National President of PGWFI**.

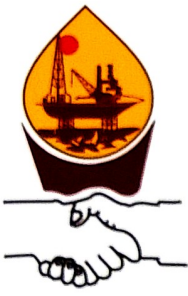
As mentioned above, the 6th Triennial Conference is being jointly organized by the unions of ONGC, HPCL, IOCL, BPCL, and PHL. The estimated budget for the two-day conference is approximately **Rs. 25,00,000/- (Rupees Twenty-Five Lakh only)**, which includes expenses towards lodging and boarding of delegates, foreign delegates, publicity, printing, auditorium charges, transportation, etc.

It has been resolved to collect a contribution of **Rs. 1,500/- (Rupees One Thousand Five Hundred only)** from each of our union members to meet the conference expenses. A video conference was conducted on **17th March 2026** with all union members, wherein the resolution was unanimously passed. It has also been decided that any member who objects to this contribution will be refunded the deducted amount.

In view of the above, we kindly request your good office to issue necessary instructions to the concerned authorities to deduct **Rs.1,500/- (Rupees One Thousand Five Hundred only)** from the salary for the month of **March 2026**.
