ONGC's Uran Plant has a regular workforce of 550 employees along with their dependents. Additionally, there are around 300 Retired employees, 250 CISF personnel & their dependents as well as 450-500 contractual employees working at the plant are staying in & around the Uran city,. Previously, a homeopathic doctor was posted at the OHC, Uran Plant & many employees availed themselves of treatment from homeopathic doctor. Currently, the position is vacant, causing inconvenience to employees seeking homeopathic care. As a result, employees are requesting the appointment of a homeopathic doctor.

As mentioned, in Homeopathy Circular No. **WOU/RO/Circular/24/27**, Dated **15/10/2024**, ONGC has already adopted a scheduled in-house homeopathy consultation model at the Medical Section through Dr. Darshan Shah & Dr. Mohini K. Jain, with consultation timings generally from 09:30 am to 01:30 pm at locations including NBP Green Heights, 11 High, Vasudhara Bhavan, Maker Tower, Helibase & Panvel. Arranging a similar weekly visit for Uran Plant would therefore be consistent with the existing consultation pattern followed within ONGC. Such a weekly visit would help meet employees' health needs, support continuity of care & reduce inconvenience to employees who require homeopathic consultation.

Your esteemed authority is requested to approve this weekly visit of Homeopathy doctor at ONGC, Uran Plant at the earliest. This interim arrangement is requested until a new Homeopathic Doctor is appointed. We shall be grateful for an early & favorable decision in the interest of employee welfare.
