Sub.: Request for Sanction of Air Travel Claim Of Shri. Nilesh D. Khapre As A Special Case.

Respected Sir,

We are in receipt of a request from **Shri Nilesh D. Khapre, Fire Inspector Grade-II, CPF No. 126394**, posted at **ICP Platform**, seeking sanction of his air travel claim incurred while travelling to his native place, Nagpur, to attend the last rites of his father, **Late Shri Devnath D. Khapre**.

A copy of his request letter is enclosed for your kind perusal.

Shri Nilesh D. Khapre was on duty at ICP Platform when he received the unfortunate news of his **father's demise on 12.11.2025**. Owing to the urgency of the situation & the non-availability of direct air tickets from Mumbai to Nagpur at such short notice, he was compelled to book a connecting flight from Mumbai to Nagpur via Delhi.

His family members were awaiting his arrival to perform the last rites. Shri Khapre had boarded the ICP Platform on 30.10.2025 & was on the 12th day of his offshore duty when he received the news.

Unfortunately, the **Mumbai-Delhi flight was delayed**, due to which he missed his connecting flight from Delhi to Nagpur. Consequently, he was required to purchase another air ticket from Delhi to Nagpur. The circumstances were entirely unavoidable & beyond his control. The total expenditure incurred on the air tickets is substantial & has placed a considerable financial burden on him.

Shri Khapre was scheduled to disembark from the platform on 13.11.2025 after completing his regular 14-day offshore duty tenure. Had he completed the scheduled tenure, he would have been eligible for regular air travel expenses under the applicable TA provisions.

Such unfortunate situations involving offshore employees are rare & exceptional. Similar claims have also been considered & sanctioned in the past in cases involving the death of an employee's dependent or close family member.



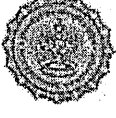

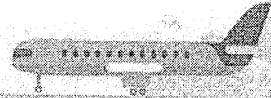
